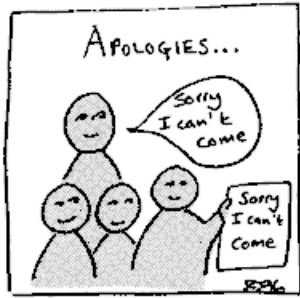

We looked at the 'Safeguarding adults in the East Riding An easy read guide to understanding and reporting abuse' document to help us.

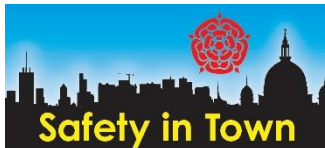

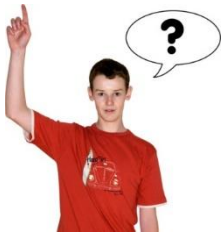
